The Holland & Hart Foundation is proud of its continuing partnership with the West Tallahatchie School District. In 2004, the Foundation collected \$4,000 to send to the District for its annual New York City Trip. This provided funds for 10 students to make the trip. Teacher Ora Johnson is the program organizer. In total, she took 34 students and a number of teachers.

In addition, the Foundation presented the first "Law Day" at Webb High School. Nick and SuSaNi Clayton (an alumna of H&H) made presentations on the law, its role in society, and the opportunities and careers available in law for these African-American high school students. The Claytons, by telling their life stories, inspired these students and let them know that they too can attain similar success.

WEBB — West Tallahatchie High School graduating senior Rashonda Roach recently was announced as the 2004 recipient of the local annu-Holland & Hart Promise Scholarship.

The award was announced during the school's recent law day festivities, held in the auditorium.

Roach, valedictorian of her class, will be presented the \$300 scholar-ship by the Holland & Hart Foundation, a non-profitable charitable and educational organization which was started in 1998 as an outreach effort of the Holland & Hart law firm in Denver, Colo.

Last year, the foundation committed to funding the annual scholarship in the West Tallahatchie School District for a period of 10 years, along with providing other needed educational materials to assist the district's schools.

Sam Guyton, a retired partner in

the firm of Holland & Hart, and his wife, Jean, were on hand to make the presentation to Roach.

Also present were Nick Clayton and his wife, SuSaNi Clayton, of Houston, Texas, who were on hand as guest speakers during law day. They also are former employees of the Holland & Hart organization.

The Claytons discussed the rocky road they traveled to reach success he now is president of The Financial Services Company of the Southwest and she, an attorney, serves as its corporate counsel.

Recounting the many obstacles which threatened their progression poverty, racism, discrimination and self-doubt, to name a few both told West Tallahatchie students they can rise above them all by staying focused, being determined yet patient and believing in themselves.

"The obstacles don't stop coming," said SuSaNi Clayton. what you do with those obstacles that makes the difference.

Saying everyone must have a road

map in life, she added people sometimes must be patient, yet stay on course. "You just keep driving until

you get to where you want to go."
Nick Clayton also mentioned other obstacles which he said likely were facing many people in the audience, including drugs, alcohol and peer pressure.

"You have a decision to make," he told students. "First, you have to recognize what your obstacles are. Then you have to decide if you are going to allow obstacles to make you lose the race of life, or whether you are going to go over them, around them or through them. If you defeat the obstacles, you can be whatever you want to be.'

In illustrating that point, he said there is no predestination for suc-cess in the business world.

"Professional people are not born.
There are no labels on the cribs in the maternity ward saying, 'This baby will be a doctor, or 'This baby will be a lawyer or banker.' Nobody makes that decision except you."

All-Firm Projects

- Tsunami Relief Fund: H&Hers raised \$13,520 for Habitat for Humanity.
- Mississippi Project N.Y. Trip:
 H&Hers made donations to fund this trip for two dozen needy children from the West Talahatchie School District.

Boulder Office

- The Parenting Place Holiday Project: H&Hers adopted a single mom with four kids through The Giving Tree, and collected over \$700 to purchase all of the items on their wish list. In addition, H&Hers donated three file cabinets, a cell phone, and lots of other office supplies to Lucee Dove, The Parenting Place volunteer in charge of *The Giving Tree*, to help set up her office.
- Blue Sky Bridge: Volunteers planted flowers in the Blue Sky Bridge garden.
- Care Packages: H&Hers sent 156 boxes of Girl Scout Cookies—one box each—to the men serving on the U.S.S. Columbia submarine.

Chevenne Office

- Cheyenne Community Clinic: H&Hers volunteered every Tuesday for this non-profit organization that provides healthcare services to those unable to qualify for medical aid or afford medical insurance. Projects included:
 - Newletters: H&Hers created, formatted, and arranged for copying and folding of 4,000+ newsletters. The clinic's last newsletter resulted in donations of over \$5,000!

- March of Dimes Walk: A team of H&Hers walked and raised money to help research for premature babies.
- Volunteers of America Meals-on Wheels: Daily volunteers delivered meals to the elderly.
- Pocket Flag Project: Volunteers sent pocket flags and care packages to military servicemen and women serving in the Middle East.

- Band Together Fundraiser: H&Hers raised over \$5,000 and volunteered at an event to benefit a local 45year-old mother of seven with ALS (Lou Gehrig's disease) and no health/life insurance, as well as other individuals with ALS.

Jackson Office

 Community Safety Network: For the past three years the Jackson office has held a cooking party which benefits the Community Safety Network, a local shelter for abused women and children.

- St. Vincent DePaul Homeless Shelter:

In one instance, the mother and father had recently fallen on hard times and were unable to provide some of the essentials to their three children. The other family was a single mother of five children. The office generously provided each family with the basics like coats, pants, socks, underwear, and shoes as well as toys, dolls, bikes, and games for the children.

- Blue Star Mothers: H&Hers donated \$878 to the Blue Star Mothers to help to prepare gift boxes for the troops overseas.
- Special Olympics: Volunteers helped children during the Olympics by keeping time, aligning the runners, acting as finish line judges, and presenting medals and trophies.




