
We are so pleased to present our 2014 Annual Report. Thanks to the tireless efforts and generosity of people from all across the firm, including each one of Holland & Hart's 15 offices, the reach of the Holland & Hart Foundation this year expanded further than it ever has before.

The Holland & Hart Foundation's firmwide efforts, like our annual holiday food drive (see page 4) continued to grow. This year's food drive collected 8% more food and cash than in 2013, allowing our office committees to distribute 29,947 lbs of food and cash contributions to organizations from the peaks around Aspen, Colorado, to the Washington Beltway. The Stern Family Summer Project received 40 submissions from young people affiliated with the firm, resulting in \$4,000 in donations being made on behalf of those children to the organizations of their choice, and teaching another generation about the value of philanthropy and importance of community involvement.

The Salt Lake City office was recognized by the Governor of the State of Utah for its "exemplary leadership... through volunteerism" following that office's 20th Anniversary Day of Service, which brought together more than 125 attorneys, staff, clients, and family for a day spent cleaning up a local school (see pages 22-23).

Our attorneys and staff cooked, gardened, shopped, organized, built, wrapped, delivered, played, and laughed together. I hope you enjoy reading about what we have been doing through the Holland & Hart Foundation this year, and, as always, please consider joining us next year!

# FIRMWIDE FOOD DRIVE

**Firmwide Food Drive**: For 15 years, the Holland & Hart Foundation has coordinated a massive effort across the firm to gather donations of money, food, and other necessities as part of the firmwide food drive.

In total, nearly 100,000 pounds of food have been donated to people and families in need.

In 2014, the annual firmwide food drive collected an astounding 29,947 pounds of food and cash, topping last year's total of 27,602 pounds by more than 8 percent.

This year's small office winner – for the fourth time running – was Carson City with another Herculean haul of 189.3 pounds per person (PPP).

The office also earned 100 bonus points for its CANdid photos, which brought them up to 214.3 PPP. For the second year running, Colorado Springs took the runner up position with 104.3 PPP.

This year's winner of the large office/floor category was the 28th floor in Denver, which brought in 76 PPP. It edged out last year's winner, Las Vegas, who came in second this year at 68.3 PPP.

Special kudos to contributors in Aspen, Carson City, Santa Fe, Washington D.C., and the 19th floor in Salt Lake City for achieving 100 percent participation.

## PARTNER RETREAT

**Idaho Botanical Garden Project**: During the September 2014 Partners' Retreat in Boise, several of the firm's partners spent their Saturday volunteering at the Idaho Botanical Garden, one of the first and oldest botanical gardens in Idaho. Nestled in the Boise Foothills, it is a sanctuary in the heart of the Old Penitentiary Historic District. The garden promotes horticulture in the Treasure Valley using native and domestic plants adapted to the intermountain region.

The crew planted native plants in the Lower Meadow at the garden, which for many years had been fairly barren and included only some large rock formations, while other garden areas were finished and enhanced. With a recent donation of \$15,000 of Idaho native plant material, the garden was graded and cultivated, irrigation sprinklers were installed, and beds were prepared for the new foliage (native flowers, plants, and grasses) that partners planted during their day of service.

Before the team returned to the partnership retreat, they enjoyed a tour of many of the Idaho Botanical Garden's 14 specialty gardens. This nonprofit organization leases 33 acres from the State of Idaho and relies on memberships, program fees, and donations to sustain educational programming, plant collections, and future development. Holland & Hart LLP partner Jason Prince is a member of the Board of Directors.

Fittingly, the garden was celebrating its 30th anniversary in 2014, while Holland & Hart celebrated 30 years since merging with Langroise Sullivan in Boise.



Mississippi Project: Twelve years ago, Louise Artibello, a secretary at Holland & Hart, was listening to NPR when she heard a story that moved her to action. The story was about "LaLee's Kin," a documentary film by Susan Froemke, Deborah Dickson, and Albert Maysles, shot in West Tallahatchie, Mississippi, that profiled Laura Lee Wallace, who was raising her grandchildren and great grandchildren in the West Tallahatchie School District, then the poorest school district in the nation. Artibello spread the word to the attorneys and staff of Holland & Hart and the Holland & Hart Foundation, who were also moved to take action. After an initial in-person donation of books, school supplies, clothes, and other items, the Holland & Hart Foundation committed to a 10-year scholarship program to recognize one exceptional student, one exceptional teacher, and one exceptional teacher's assistant each year. After fulfilling the first 10-year commitment, the Board of Directors voted in 2014 to extend the program.

The 2014 recipients are Ashley Rucker, who was awarded the Promise Scholarship; Reshondra Lakes, who received the Outstanding Teacher of the Year Award; and Donna Love, who received the Outstanding Assistant Teacher of the Year Award.

**Stern Family Summer Project:** Now in its eighth year, the Stern Family Summer Project – made possible by the generous support of long-time Holland & Hart client and Holland & Hart Foundation donor, the Stern family – helps the sons, daughters, nieces, nephews, and grandchildren of attorneys and staff at Holland & Hart learn the value of philanthropy and volunteerism from an early age.







**Adopt-a-Family for the Holidays:** The Aspen office adopted a family of six for the holidays through the Aspen Interfaith Association. The program received 100 percent participation from attorneys and staff who purchased gifts, stockings/stocking stuffers, wrapping paper, and other holiday goods for its adopted family. The recipients of this holiday program live in the Aspen and Basalt areas and are referred to the program by local social service agencies. Area churches, synagogues, schools, other local groups, and individuals participate in acquiring, collecting, securing, assembling, and distributing the collected gifts. In 2014, this program served more than 250 families in the area.

Heritage Park Care Center: The entire Aspen office participated in providing Holiday gifts to senior citizens who are residents of the Heritage Park Care Center, a nursing home in Carbondale, Colo. The Aspen office received a list of desired gifts from nearly 60 residents, many of whom do not have friends or family in the area. Staff and attorneys worked to fill the lists to the best of their abilities in an effort to give the residents some Christmas cheer. The team also delivered numerous boxes of chocolates, fleece blankets, books, and warm clothing that were purchased specifically for the residents.

**United Way Day of Caring:** In September 2014, employees and family members of the Boulder office participated in the United Way Day of Caring. Participants volunteered for a project at the Boulder Humane Society where, among other tasks, they worked together to refresh living spaces in the dog adoption center and to clean and restore the training and behavior center.

Crayons to Calculators: In July 2014, the Boulder office donated 225 backpacks full of school supplies to Crayons to Calculators, a school-supply drive that helps local students head back to school with all the tools they need to succeed. The organization helps to provide 8,000 students in the Boulder and St. Vrain Valley School Districts with supplies each school year. The Holland & Hart Foundation's cash and in-kind donations exceeded \$3,000, which allowed the Boulder Committee to provide 225 backpacks filled with supplies for distribution to students in grades 3-5.

**2014 School Supplies Drive:** The Colorado Springs office collected school supplies and cash for Catholic Charities of Central Colorado to distribute to low-income families in the community through various Marian House programs and services. The Marian House organizations include Marian House Life Support Services, Marian House South Kitchen, Marian House Community Outreach Services, Marian House Client Services, Family Immigration Services, and Life Connections. The programs serve more than 4,000 children.

**WOW Harvest Festival:** The Colorado Springs office won first place for the scarecrow, "Scaryl Crow," which volunteers created and donated to the WOW Harvest Festival in October. Donated scarecrows sold during the festival raised more than \$6,000 for the WOW organization. WOW provides an interpersonal connection with families and individuals that have or are dealing with similar life experiences, such as military families, families who have a seriously ill child, and families that have lost a parent or a child. The organization's CONNECT program includes family activities and outings, offered regularly to give families a chance to have fun together away from the hospital so they can relax, regroup, and return home with a renewed sense of strength and hope.

Ronald McDonald House Holiday Toy Drive and Fundraiser: This year for the holidays, the Boise office raised funds and contributed more than \$1,000 worth of warm winter clothing, pajamas, outerwear, and baby toys to Ronald McDonald House Charities of Idaho, Inc. The organization operates the Idaho Ronald McDonald House (RMH). Each year, RMH sets up a "Santa's Workshop," where guests of the house can shop for gifts for family members. The gifts include toys, books, electronics, games, clothing, toiletries, and gift cards for haircuts, restaurants, grocery stores, gas stations, and other necessities. RMH provides a temporary home-away-from-home for families of ill or critically injured children receiving treatment at Boise medical facilities. The house, located just down the street from the firm's Boise office, has 19 rooms and is frequently at-capacity.

**Idaho Foodbank Backpack Program Volunteer Day and Food Sort:** In September 2014, a group of Holland & Hart Foundation Boise volunteers visited the Idaho Foodbank warehouse in Boise to assist with its Backpack Program and the sorting and packaging of food donations. The Idaho Foodbank is the largest hunger-relief organization and the largest distributor of free food assistance in Idaho. The Backpack Program began when an inner-city school nurse asked for help. Each Monday morning the same students came to her with stomach aches and dizziness; she realized that they had not eaten since their free school lunch the Friday before. School officials responded by sending home food on Fridays but made the mistake of putting the groceries in paper bags which made children feel singled out. When the weekend meals were placed into backpacks, children felt more comfortable taking the food.

Volunteers for the Idaho Foodbank helped build these backpacks by working shifts in assembly-line fashion, placing the various food items into plastic bags which are then distributed to needy students for placement into their backpacks. The Idaho Foodbank relies on volunteers to complete the backpack builds. After assembling more than 600 backpacks, the Holland & Hart Foundation Boise team helped with sorting and packaging other donated food.



Santa Fe Indian Market Parking Fundraiser: Each year, the Santa Fe office holds a fundraiser in conjunction with the Santa Fe Indian Market, a Native art market that has existed for more than 90 years. It is the largest and most prestigious Native art market in the world and the largest cultural event in the southwest attracting approximately 100,000 visitors to Santa Fe from all over the world. Over 1,100 Native artists from the U.S. and Canada sell their artwork at this event held annually during the third weekend of August. Buyers, collectors, and gallery owners come to Indian Market to take advantage of the opportunity to buy directly from the artists and to meet the artists and learn about contemporary Indian arts and cultures.

Because the Santa Fe office is located near the art market and has ample parking, the office charges \$20 per car for parking during the event to raise funds for Santa Fe office projects. Volunteers from the office sign up for shifts and watch the parking lots all day Saturday and Sunday. This year, the office raised \$810 dollars during the two-day event. The Santa Fe Committee will be using this money to fund its 2015 charitable projects.

**Food Depot:** Each month, the Food Depot supplies food to people in need through 120 partner agencies in nine Northern New Mexico counties, including homeless programs, youth programs, group homes, senior centers, day care centers, domestic violence shelters, and more. In February 2014, the Santa Fe office donated \$640 along with cans of food to support this cause. Friday Food Bag Foundation: A program started by the Cheyenne office in 2007 has snowballed into a communitywide project and nonprofit foundation that is now delivering more than 800 bags of non-perishable food every week to students and their families who otherwise would go hungry over the weekend. The program, now formally known as the Friday Food Bag Foundation, began as a community service project of the Cheyenne office to provide weekend meals to students who qualify for the free/reduced-cost lunch program in Laramie County schools. Many of those children were able to eat a hot lunch at school but had very little or nothing to eat most evenings and over the weekends. Using seed money from the Holland & Hart Foundation as well as individual donations, staff and attorneys purchased single serve, non-perishable, easy to prepare food items, packed them in bags and delivered them to the schools for distribution. Word got out in the community and donations from individuals, firm clients, civic clubs, and churches started pouring in. By the end of 2009, the program had become too big for the office to handle alone. With donations and help from Kiwanis and a few other major donors, a separate nonprofit foundation was established.

Habitat for Humanity: In June and early August, employees and family members of the Cheyenne office helped build the 2014 Habitat House in Cheyenne to benefit a single mother and her two children. Work included sheet rocking, sanding, and painting walls. In addition to showing support for the community and the Holland & Hart Foundation, volunteers worked to help honor the memory of Tyrel Zeringue, the deceased son of legal secretary Lynda Zeringue, who volunteered with his family on the first two Habitat homes built in Cheyenne in the mid-to-late 90s. Anchored by the conviction that housing provides a path out of poverty, since 1976 Habitat has helped more than 5 million people through home construction, rehabilitation, and repairs and by increasing access to improved shelter through products and services.

**The Santa Fund:** The entire Jackson office participated in serving as elves for 17 children through the Santa Fund, a nonprofit organization which provides Christmas presents for underprivileged children in Teton County, Wyo. The fund gives each "elf" approximately \$140 to spend per child. The elves then donate their time and energy to shopping for presents, wrapping gifts, and dropping the packages off for parents to pick up the week before Christmas.

Cooking for Community Safety: The Jackson office and many family members gathered in November to cook meals and freeze them for the local domestic violence shelter, Community Safety Network. After making grocery lists, recipes, and grocery shopping, 100 percent of the Jackson office participated in chopping, slicing, dicing, grating, and cooking the delicious homemade meals. The Community Safety Network provides support, advocacy, shelter, and assistance to those affected by domestic violence, sexual assault, and stalking. According to Teton County law enforcement, these crimes are considered the most underreported crimes in the community. With donations and volunteers from throughout the Jackson community, the Community Safety Network provides shelter and support to more than 500 clients and their children in addition to reaching thousands of teens and adults with education and outreach programming.

# LAWYERS IN THE CLASSROOM

Lawyers in the Classroom: Over the past two years, nearly 100 Holland & Hart attorneys have volunteered in approximately 40 Denver Public Schools' fifth-grade classrooms through the Lawyers in the Classroom program. The success of the ever-

growing program has teachers signing up by the dozens and attorneys coming back year after year to volunteer. In 2015, at least 56 Holland & Hart attorneys will participate in 24 classrooms.

Lawyers in the Classroom is a program founded by the Constitutional Rights Foundation Chicago (CRFC) that allows attorneys to volunteer in generally lower income elementary and middle school classrooms to teach students about basic aspects of our country's laws and constitutional rights in a fun and engaging format.

To facilitate the program, the Holland & Hart Foundation has partnered with a local non-profit, the Center for Education in Law & Democracy (CELD), to coordinate with Denver Public Schools and identify classes for participation. The volunteer attorneys work in groups of two or three and make three classroom visits during a semester.

Lawyers in the Classroom offers participating attorneys and the Holland & Hart Foundation the opportunity to make a real impact on a significant number of local schoolchildren in Denver, where the public high school graduation rate has historically hovered around 50 percent.

In a thank-you letter written after last year's sessions, one fifth-grade student had this to say: "You did a magnificent job teaching us about our country's rights. ... You guys were very nice and have made a huge impact on my 5th grade year. (In a positive way!)"

# LEADERSHIP



Launched in 1998 by Holland & Hart partner Sam Guyton and his wife, Jean, the Holland & Hart Foundation is a 501(c)(3) organization with three primary goals:

- 1. Create opportunities for individual and group volunteerism at Holland & Hart
